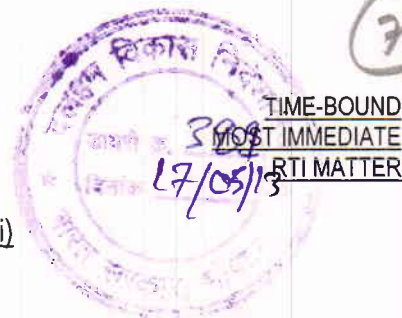

**Answer 1:** Purpose of TAs Recruitment is to i) Assist authority and the Technical officers of the Directorate for overall monitoring of Accelerated Pulses Production Programme (A3P) and all other activities related to NFSM, ii) Collection and compilation of relevant information related to NFSM, iii) Collection, scrutiny and compilation of progress report of NFSM, iv) To maintain relevant record / data of the NFSM activities, v) To undertake field visit to assess the progress of NFSM and related activities, and vi) To undertake other work assigned by the authority and the Technical officers as and when required.

Prescribed qualification and criteria for selection: These are i) Master Degree in Agriculture Science (M. Sc. Ag.) from a recognized university / Institute, ii) Knowledge of computer operation and iii) Person with field experience will be given preference.
